Call for Interest: HbbTV Test Material Maintenance

Responses will be treated as Confidential

HbbTV Association is surveying interest from companies to provide Maintenance Services for the HbbTV Test Suite.

Any orders for maintenance services awarded by HbbTV going forward will be made under a new Test Material Maintenance Agreement v1

(https://member.hbbtv.org/wg/Licensing/document/7430?downloadRevision=10286).

NOTE: the TMMAv1 is principally a time and materials style contract.

We would anticipate awarding orders to a small number of companies, with each order comprising around 1 years' worth of activity.

A snapshot of the <u>current level of outstanding items</u> are as follows:

TMP Status	New issues (no triage yet done)	Pending issues (triage done)
Non-active TMPs (1)	42	10
Active TMPs (2)	58	19

(1) "Non-Active TMPs" refers to tests where the original provider of the tests to HbbTV no longer participates in test material maintenance for HbbTV.

(2) "Active TMPs" refers to tests where the original provider of the tests to HbbTV still participates in test material maintenance for HbbTV. At the present time, this set of tests excludes the Targeted Advertising tests the maintenance of which is being done by a particular TMP.

Based on past activities, the rough estimate of HbbTV is that this set of issues will represent between 100 and 150 days of work in aggregate, assuming work is performed by engineers with appropriate IT/HbbTV/DVB skills.

Please note that the contract(s) to be awarded by HbbTV are time and material oriented so that it is not expected from bidders that they will commit to treat a given number of issues, but that they will provide a given amount of work hours directed to these issues (to be assigned by HbbTV). New issues are continuously being discovered and this shows the state of the current backlog. New issues that are reported during the period of the contract(s) will be allocated to selected suppliers as they arrive.

All responses will be handled in confidence by HbbTV's Supplier Evaluation working group.
